



THE UNIVERSITY OF BURDWAN

The University of Burdwan offers admission to foreign nationals under self-financed basis by following UGC guidelines for admission and supernumerary seats in various Under-graduates and Post Graduates courses of studies and also to pursue Ph.D.

ICCR Applicants

ICCR applicants are nominated/sponsored by Government of India under various Scholarship Schemes of the Indian Council for Cultural Relations (ICCR). Candidates are advised to contact the nearest Indian Diplomatic Mission for necessary information about these scholarships.

Foreign Students and NRIs

Foreign students and NRIs may take admission to this University on **self-financed basis** upon fulfilling eligibility criteria of the programme of their choice. Minimum eligibility qualifications for foreign students will be the same as for Indian Students for each course/program as is determined by the University authority from time to time. Admission to such candidates shall be offered following necessary approval of the University authority and in compliance of the guidelines for admission and supernumerary category as may be determined by the University Grants Commission from time to time. Applicants seeking admission on self finance basis are advised to keep in touch with the official website of the University www.buruniv.ac.in and send their applications to **International Student' Cell** accordingly.

Guidelines and Rules for Admission

1. Minimum eligibility criteria for foreign students will be the same as for Indian Students for each course as is determined by the University authority following the guidelines of Ministry of Education.
2. English translation of all transcripts, duly attested, is to be submitted along with application.
3. Applications without the attested documents shall be summarily rejected.
4. The admission criteria of the foreign students who want to pursue courses of their choice on self-financed basis shall be determined by the University authority
5. On being granted admission, all applicants should produce their valid Passport and Students Visa issued for pursuing the respective course.
6. Foreign students are to produce AIDS Certificate from both the Governments (India and the Country from which the candidates intend to prosecute their studies here).
7. Students are to produce Resident Permit from the Superintendent of Police/Registration Officer, DIB of the locality in West Bengal, India.
8. No Objection Certificate from the Ministry of Education, Govt. of the Country from which the candidate intends to come is to produce by the students.
9. Any other valid documents as may be required for Foreign Students from time to time as per orders of the Govt. or the University Authority are to be submitted by the Students.

10. Upon arrival in India every Foreign Students must register with the Foreigners Regional Registration Office (FRRO) within fourteen(14) days from the date first entry into India as per prescribed applicable procedure as laid down by Government of India.
11. The course/program once filled in the application form shall be final and cannot be changed at any later stage. Once admitted, all foreign students shall pay the fee as per prescribed fees structure of the University for Foreign Students. However, the University may revise the fee at any time subject to approval of the appropriate authority.

Fees and scholarship:

For any query regarding the academic fees, course fee, hostel charges etc., the students are to contact the office of the International Students' Cell during the office hours.

Accommodation:

The University has a dedicated state of the art International Students' Hostel in the campus for accommodation facility extended to the International Students. The Hostel charges for accommodation are on actual basis or as may be determine by the University authority from time to time.

Banking:

International Students on ICCR fellowship are required to open Savings Bank Account at the State Bank of India, Burdwan University Branch. International Students admitting themselves on self –finance basis can open Savings Bank Account at the said Bank and Branch.

Apart from the above requirements the incumbent the foreign students are to keep in touch with the International Student Cell throughout their stay in this University. The International student Cell extends its assistance to the Students/Scholars from overseas in admission process and monitors their activities, maintains liaisons with the sponsoring agencies and extends all sorts of co-operation to the students round the clock and takes care of their problems, if any, faced by them.
